Here are the advantages of signing up for electronic delivery:

1. Enroll for electronic W-2 statements for easy online access to view, print, email or fax at your leisure.
2. Have access to your W-2 up to two weeks sooner than getting it in the mail.
3. No more worry about delivery issues through the U.S. Postal Service.
4. Have access to print as many copies as you need throughout the years activities, such as getting home loans or income verification.
5. No waiting for reprinted W-2 statements that could take weeks to receive.

How to enroll for your electronic W-2 statement:

The deadline to enroll is Dec. 31 of each year; so follow these steps as soon as possible, so you get it done before the end of the year:

1. Log in to PeopleSoft Self Service
2. Navigate to: Self-Service > Employee > Tasks > W-2 Electronic Consent

Note: If you have already enrolled in a prior year, you do not need to enroll again. However, using a personal email instead of your work email when accessing the Global Cash Card website helps in the event you leave your employment. You can still access their website regardless of your employment status.
